
Course Objectives

- Explore the emergency management cycle including preparedness, response, recovery, and mitigation.
- Analyze the roles and responsibilities in emergency management this includes local, state, and federal government, the private sector, and non-governmental organizations.
- Investigate the global environment of emergency management.
- Be exposed to special topics in emergency management such as resilience, vulnerable populations, disaster mental health, crisis communication, and corporate social responsibility.

Course Requirements & Assignment Weights

Orientation (5%) - Students will complete a syllabus quiz and an introduction post on D2L.

<u>Weekly Reading Reflection (20%)</u> - Each week you will be required to submit a 1-page reflection responding/reacting to the chapter reading. I do NOT want a summary of the reading; rather, I want to read what you thought about the content. What feelings do you have? What does it remind you of? Do you have a personal experience related to it? I'm open to reading pretty much anything but a direct summary.

<u>Weekly Applied Activities (30%)</u> - Each week you will use the knowledge gained and apply it to a real-world problem in emergency management.

<u>Completion of FEMA Independent Study courses (20%)</u> – You will need to register for a free FEMA SID Number before you can complete these free independent studies. These "courses" are the basic requirements for any emergency manager to have. You do not need to be a U.S. Citizen to register for a FEMA SID or to complete the courses. You will upload your completion certificate to Assignments in D2L for credit.

Assignments and Extensions

Assignments are expected to be turned in on time. An automatic 5% per day will be deducted for any late assignment. Contesting Grades

If you have received a grade on an assignment that you see as unfair, you have the right to contest the grade with a written explanation sent to me by email. I will consider it, but I reserve the right to give the grade initially given with an explanation of why your request was denied.

Final grades will NOT be changed. You will have had ample opportunity to contest your grades on assignments and/or exams. For example, while figuring final grades, if I find you are one point away from the next highest grade, you will receive the lower grade. If you are .1 point from the next highest grade, you will receive the lower grade. I will NOT raise your grade at the end of the semester if you are one or two points away from the next higher grade. What you earned is what you get. If I do it for one person, I will have to do it for all.
